Minutes of the 7th Annual General Meeting of The Forensic Science Society of Malaysia held on Thursday, 19th March 2015, at 11.00 a.m. at Atlanta Ballroom, Hotel Armada, Petaling Jaya, Selangor

The 7th Annual General Meeting of the Forensic Science Society of Malaysia was chaired by its President, Mr. N. Hithaya Jeevan and was attended by 83 members of the Society.

Agenda 1 : Address from the President.

- 1. Once again, it gives me great pleasure to welcome you all to the 7th Annual General Meeting of the Forensic Science Society. A warm welcome is also extended to new members as well as old members who are attending FSSM AGM for the first time.
- 2. For the first time we are having our AGM in conjunction with a forensic science symposium. This was our main event for the year 2014-15. It was great to have so many interesting topics for the plenary talks. I hope we all benefited from these talks, the oral presentations and the posters as well from the interactions between us, members of the forensic community.
- Additionally for the benefit of members, we have also arranged for an interesting workshop by Agilent Malaysia this afternoon titled New Analytical Instrumentation Technologies for Forensic Applications
- 4. We had two other seminars during the year, one for students at the USM KB campus, jointly organized with USM and the other a DNA seminar by Dr. Bruce Budowle, a distinguished scientist from the USA, organized in collaboration with Science Vision Sdn. Bhd. The secretary will provide more details during the presentation of his report. I believe there will be many more opportunities for such collaborations with companies in the future.
- 5. During the year, i.e. on 21 June 2014, FSSM had its Strategic Planning Session at Hotel Puri Pujangga, UKM attended by a total of 18 FSSM members of which 8 were non-council members who kindly sacrificed their weekend for us. Yours truly was the facilitator.
- 6. We had an interesting full day session and were able to come out with the strategies for the next 5 years to chart the way forward for FSSM. However, because of other priority commitments the group could not gather for a second session to formulate the action plans. I shall present the draft strategic plan after this and shall then leave it to the incoming council to proceed thereafter.
- 7. Ladies and gentlemen, with regard to the membership, on record we have more than 400 members and here again the Secretary will provide the detailed breakdown shortly. However, I have to admit that there is a need to clean up the membership database as some have not paid their dues while several student members may have moved on after graduation and are not traceable. This year again, I appeal to all members to pay their annual fees on time.

- 8. Our very own Malaysian Journal of Forensic Sciences was posted as Volume 5 Issue 1 with several interesting articles. Please visit our website. I would like to thank the editorial committee ably led by Dato' Dr. Yew and Dr. Fahmi Lim and the contributors as well.
- 9. Regarding the financial situation, the balance as of 31 Dec. 2014 stood at about RM 48,000, i.e. a sum similar to our status a year ago. The treasurer will provide details during his presentation later.
- 10. I would like to take this opportunity to record my appreciation to all the council members for their efforts and contribution over the last 2 years, as our term of office is expiring today. As the outgoing President, I would like to specifically mention a few names who have actually put in a lot of hard work to sustain the Society The Secretary, Mr. Pathi, our e-journal editor Dr. Fahmi Lim who is ever present at meetings in spite of having to travel all the way from Kota Bharu, our treasurer Dr. Khairul Osman alias Dr. KO, Puan Rosnah Awang who was in charge of membership, our two enthusiastic young ladies asst. treasurer Dr. Vanitha Kunalan and asst. secretary Cik Siti Nur Musliha, and our handyman and multi tasking council member Mr. Iskandar. The moral support came from the seniors like me, SAC Dato Dr. Yew, our Deputy President, SAC Tuan Narenasegaran, Mr. John Horswell, Mr. Pua Hiang and Assoc. Prof. Dr. PT Jayaprakash.
- 11. My appreciation also goes to members of FSSM for their support. And as you all are aware, there will be elections for 13 council members today for a term of 2 years. Please chose wisely and my advice is to ensure representation from all relevant agencies/organizations and the academia. Having said that, please also be informed that I would not be seeking re-election as I have held the post of President for 3 terms, the last 6 years. I have done what I could with the help of the council members and it is time for FSSM to move on with new and bold ideas.
- 12. And before I end, just a word of thanks to the D.G. of Kimia Malaysia, for allowing the FSSM Council to continuously use its meeting facilities.
